Lifeguarding Instructor Course
2018

REGISTRATION and TUITION INFORMATION:

This intensive 10 day course (spread out over 5 weeks) for Lifeguard Instructor candidates is by advanced registration only.

REGISTER for the course with the **NJPMA** by completing the attached form. The form and course tuition (\$275.00 for members and \$325.00 for non-members) must be received by Al Taliaferro on or before 4:00 p.m., Wednesday, May 16th, 2018. Any registration after May 16th will be subject to a \$25.00 late fee. Tuition includes all materials. You can check if your facility is a member by checking the www.njpma.org website.

PREREQUISITES: Candidates must be at least 17 years of age as of June 20th, 2018. NO EXCEPTIONS CAN BE MADE.

Candidates must possess a current American Red Cross certificate for Lifeguarding / First Aid / CPR / AED (or equivalent; see page 2), strong swimming skills, and pass a pre-course swimming test on May 22nd. Proof of age must be presented at this screening session. A current driver's license is acceptable proof. **Photocopies of Birth Certificates must have a raised seal for acceptance as proof of age. Once the course tuition is received, you will receive an email with instructions for **completing the required online Introduction to the Lifeguarding Instructor course, which includes a Lifeguarding knowledge test.****

SCREENING INFORMATION: The Precourse Session (screening test) on May 22nd will check for mastery of First Aid, CPR, swimming and Lifeguarding skills. Refunds (less NJPMA administrative and materials costs of \$75.00) will be mailed only to those candidates who do not pass the screening test. There will be NO REFUNDS for candidates who drop out once the actual course begins.

PREREQUISITES FOR INSTRUCTOR CANDIDATES

To be eligible for the instructor course, instructor candidates must:

- Be at least 17 years old on or before the last scheduled day of the instructor course.
- Possess one of the following:
 - A current American Red Cross certificate for Lifeguarding / First Aid / CPR / AED.
 - A current American Red Cross certificate for Lifeguarding / First Aid and either an American Red Cross Certificate for CPR / AED for the Professional Rescuer or an American Red Cross certificate for CPR / AED for Lifeguards.
 - A current equivalent certificate from another organization
- Successfully complete the Online Session for the Lifeguarding Instructor course, which consists of the following:
 - Orientation to the American Red Cross
 - Orientation to the Lifeguarding Instructor Course and Precourse Exam
- Successfully complete the Precourse Session (screening test).
- Obtain the *Lifeguarding Instructor's Manual* and *Lifeguarding Manual* (included in the tuition fee) after you have successfully completed the Precourse Session.
